## Publishing Agreement

1. This Publishing Agreement is entered into between the Artist and the Publisher Snap Collective Publishing K/S .
2. The subject matter of this Agreement is the photographic work as submitted by the Artist to the Publisher.
3. The Publisher shall provide the Artist
  1. with a free high quality publishing service
  2. free copies according to the chart provided to the photographer
  3. discounts according to the chart provided to the photographer in case the Artist wants to buy the book
  4. processing and security the Artist's data in accordance with the Publisher's Privacy Policy to ensure the publishing process and the marketing of the Artist's Work.
4. The Publisher has the right to
  1. reproduce, print, distribute and market the Work
  2. make extracts from the Work available to the public and to make review copies available to the media
  3. transfer the publishing rights of the Work to another publisher within the Snap Collective Group.
5. The Artist shall
  1. remain the copyright holder of his/her photographs
  2. be able to publish the photographs in whole or in part with other publishers or by him/herself
  3. support the publisher's pre-order campaigns by one hour communication per day by e-mails/ Instagram/Facebook (DM)/ Whatsapp to his fans & followers during this period.
6. The Artist agrees
  1. to provide originally owned content to the publisher

2. to take full responsibility for the content of the Work, including but not limited to obtaining permission from models / people / content of photographs included in the Work
  3. ensuring the rights of use of all data contained in the Work
  4. submit the preferred layout of the Work with a specific sequence of photographs at the Publisher's discretion. The publisher will prepare a layout of approximately 10-12 pages which, once submitted by the Artist, will be applied to the entire book in this style. After completion of the overall layout/book, the Artist may make changes/corrections once within one week after reviewing and checking
  5. to deal with all claims of third parties that have arisen in connection with the content of the work
  6. to provide /update the Artist's information for the Publisher.
7. The Agreement shall commence on the date on which the Artist confirms it on the Publisher's website. The Artist receives a copy by e-mail with his used ip address.
8. If the Artist breaches these provisions, the Artist shall indemnify the Publisher against all third party claims in connection with the content of the Work, including but not limited to legal costs.
9. Both parties have the right to terminate the contract with a notice period of sixty days. The termination must be in writing by e-mail or letter.
10. Upon termination of the Contract, the Artist revokes all rights granted to the Publisher beforehand.
11. The law of Denmark and the European Union shall apply to matters not governed by this Agreement. The place of jurisdiction for all disputes shall be the registered office of the Publisher. In the event of any dispute, the parties agree to negotiate. If negotiations fail, the matter shall be resolved in the courts of Denmark.
